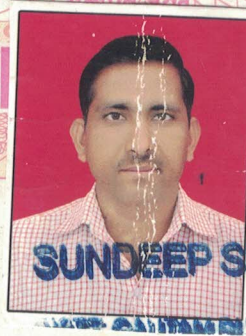

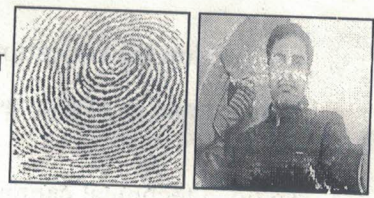

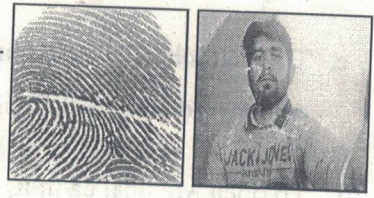

5. Trust Management and Rights and Duties .of Trustees

(a) All the two trustees will be the whole life trustees (Lifetime Trustee). They can not be removed from the trust.

(b) Any person may be appointed as the trustee to which the managing board of trust think fit to the trust to take from and give help to them.

To Conduct training and other activities under CSR programs.

(c) No person belonging to the outside would have the right to interfere in the matters of the trust

(d) To arrange fund for the trust

(e) To invest fund and to sale or purchase movable or immovable property for the benefit of the trust.

(f) To receive donation! grant, gift and loan from various persons, organizations, societies, trusts, firms, companies and government bodies and invest the fund for achieving the goals of the trust

(g) To make rules and regulations for doing social work and to achieve goals of the trust

(h) To execute joint venture with other persons, organization, society and trust for achieving the objectives of the trust

(g) The two lifetime trustee will form the managing board of trust.

Trust cannot own or claim ownership of the registration/office address of the trust.
Office address is only for communication purpose.

- (i) Managing board of trust or any person as decided by the board of trustees will take care of books and accounts of the trust.
- G) Managing trustee will call board meeting of trustees , will record proceedings of the board meeting and will take action on the decisions taken in the board meeting.
- (k) The trustees may form separate committees for achieving the objectives of the trust in which any person which may be think fit by the trustees may be the member of these committees. The trustees may reorganize these committees at times.
- (l) The decision taken by majority of trustees will be the final decision and in case of any conflict the decision of will be by voting among board of trustees execute the activities of the trust .
- (n) All the two trustees will remain the trustees for their whole life, they are free to appoint any person before or after their death provided such appointed trustee must not be mentally retard or fully handicapped. Their rights and duties will be

the same.

- (o) In case any trustee' trustees could not appointed any trustees in his place then the board of trustee will have the right to appoint the trustee in his place. Such trustee will be the whole life trustee and his right and duties will be same .
- (p) In case the lifetime trustee could not appoint any trustee in his place after his death then his older son/daughter will be the trustee in his place, if he/she refuses then his younger son/daughter will be the trustee in his place, if he/she also refuses then the managing board is empoved to appoint any persons they find fir or it they can't find anyone fit, they can keep the port vacant, or dissolve it.
- (q) Managing Board of Trust will have the power to replace any trustee at any time and may appoint any person in his place

6. Powers of Trustees

- (a) All the two trustees will Open account of the trust at post office or any nationalized bank (The. account will be operated solely by the authorized by board of trustee
- (b) The fund of the trust will be invested in fixed deposits, bonds, saving certificates and saving schemes, which will be operated by the managing trustee
- (c) Any part or the whole of the income or the accumulated fund of the trust may be donated to any trust or society which have the same objectives of the trust

- (d) To appoint constituted attorney or agent in the board meeting of trustees , to delegate some powers to such attorneys or agent and to revoke or amend these powers time to time ..
- (e) Board of trustee will have the power to purchase or sell, mortgage or lease movable and immovable property for the trust
- (f) In case of any dispute regarding the trust the trustees may compromise in board meeting, may appoint arbitrator, may get the arbitrator appointed or may file suit in the appropriate court of law
- (g) The rules and regulations of the trust may be changed or amended by the consent of the majority of the trustees at the board meeting
- (h) Two third majority is compulsory to pass any proposal in the board meeting of the trustees
- (i) Neither the personal liabilities of the trustee will be payable by the trust, nor any liability or loss incurred by the trust will be born by the trustees personally
- (j) The trust may be amalgamated with any society or trust of the same objectives after full consent of the trustees
- (k) Trustees will not be entitled for any salary or remuneration but they may claim actual

expenses incurred for the execution of the trust activities

- (1) The place of trustee will be assumed vacant in case of declaring him lunatic, being fully handicapped, declared insolvent or punished by any legal court.

(m) Dissolution of Trust

In case it becomes impossible to run the trust and becomes necessary to dissolve it, in such case the trustees will pass unanimously a resolution to dissolve the trust and to donate its movable and immovable property to any society or trust having the same objectives but in any case any trustee will not be entitled to take any part from the trust property directly or indirectly.

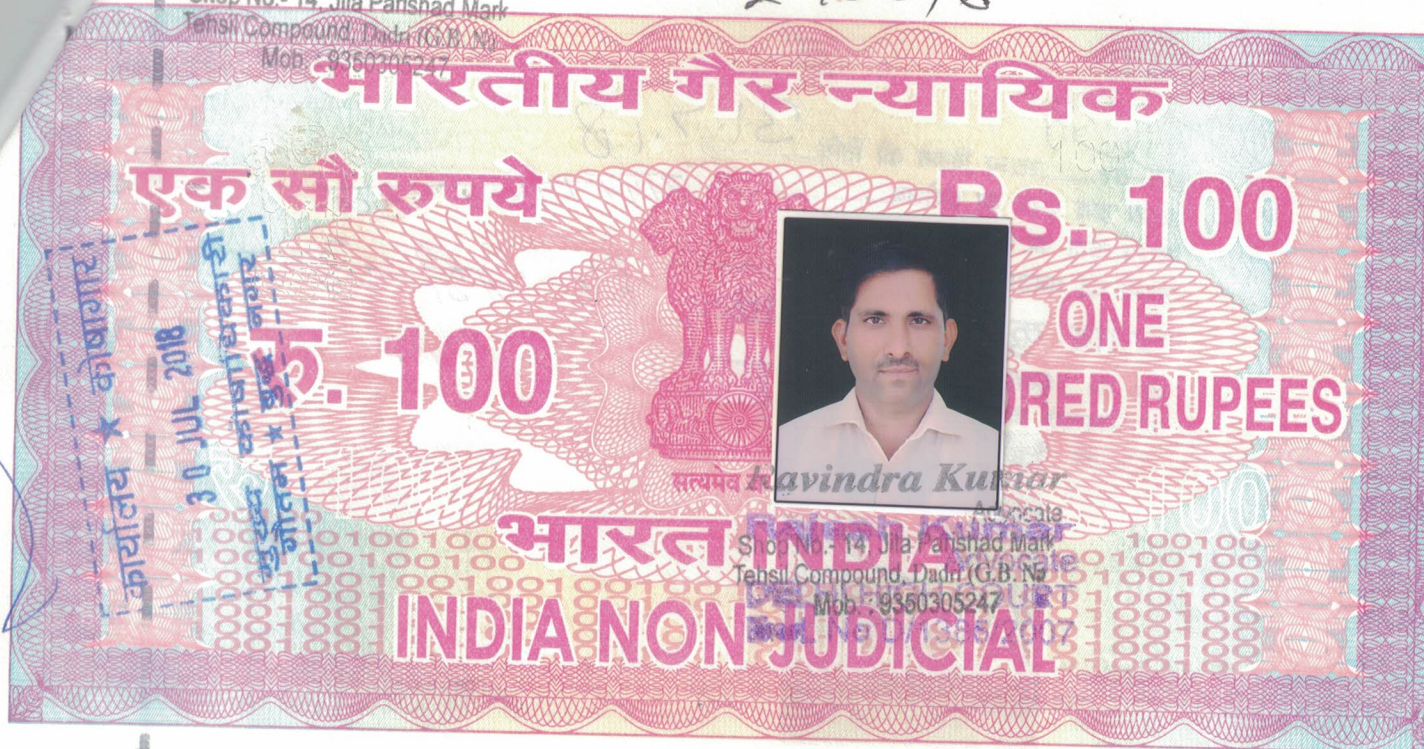
